ELITE started in 2012 from an idea of Borsa Italiana, in collaboration with the Academy London Stock Exchange and some of the most prestigious Italian Organizations, such as the Ministry of Economy and Finance, Confindustria, Associazione Bancaria Italiana, Fondo Strategico Italiano, SACE, SIMEST, Fondo Italiano d'Investimento and Bocconi University.

The aim of the program is to support the not listed companies that have a high growth potential in the realization of their development projects. ELITE offers to the companies that join the program the occasion to access new financial opportunities through a platform of integrated services, while improving their visibility through the creation of a network with potential investors, and supporting the management in growth and improvement process of the internal culture of the companies.

Nowadays, ELITE counts more than 300 companies taking part in the program, over 150 advisors and 80 investors in all Europe.
